

Markham Chinese Baptist Church – UK Mission Trip Debrief

Rev. Steven Ng

July 7–14, 2025

Background

Since 2019, the number of Hong Kong residents relocating to the UK under the British National (Overseas) scheme (BNO) has grown significantly. As a result, Cantonese-speaking communities from Hong Kong have become established across various regions in the UK. This mission trip visited three regions—South West, Middle, and North West—to assess how local churches are responding to this demographic shift. The visit focused on hospitality, resettlement needs, church life support, and gospel outreach strategies. Each region was assessed using a structured interview-based questionnaire. (see appendix I)

Region Focus: South West – Southampton & Camberley

Section I – Interviewee Background

1. Length of Stay in the UK:

Most families have been in the UK for less than five years, with children enrolled in primary and secondary schools. The group also includes university students and a few single professionals.

2. Reasons for Choosing the Region:

- **Southampton:** Families cited a relatively safer environment compared to other cities. The presence of the University of Southampton, which attracts a growing number of BNO students, was a key factor.
- **Camberley:** Interviewees were drawn to its quiet and traditional British setting, reputable high schools, and proximity to London (approx. 45-minute train commute), which provides good job opportunities.

3. Major Challenges Upon Arrival:

- Employment and job-seeking difficulties
 - Children's education and school system adjustment
 - Language and cultural barriers
 - Adapting family relationships
 - Community integration (noted as an ongoing challenge)

Section II – Church Situation and Responses

Southampton

- Southampton Chinese Church owns a primary meeting facility and rents additional venues to support ministry expansion.
 - The new Cantonese morning worship service draws approximately 150 attendees each week.
 - A new Cantonese-speaking Christian Campus Fellowship (CCF) has been established at the University of Southampton.
 - A full-time pastoral couple from Hong Kong has recently joined the church staff.
 - Over half of the church's deacons are BNO holders, reflecting the demographic shift in leadership.
 - The children's ministry faces language challenges, as many volunteers prefer to use Cantonese and Chinese-language materials due to limited proficiency in English.
 - There is a critical need for trained volunteers in children's and youth ministries.
 - Home groups are expanding to meet the needs of growing attendance and to foster deeper community connections.

Camberley

- Abundant Life Ministry (豐盛教會) is a newly launched Hong Kong-focused initiative under the UK's mainstream denomination High Cross Church.
 - The ministry is led by one full-time pastor from Hong Kong.
 - Sunday services, held at High Cross Church, currently draw around 50 attendees.
 - Due to ongoing growth (projected to exceed 100 attendees), the ministry is considering the launch of a second worship location.
 - The estimated local BNO population is between 2,000 and 3,000, indicating significant outreach potential.

Section III – Church Partnerships and Mission Needs

1. **Potential Support from Canadian Chinese Churches:**
 - Preaching and teaching support
 - Topical training (family, education, cross-cultural adjustment)
 - Fellowship/youth ministry leadership assistance
 - Counseling
2. **Preferred Collaboration Models:**
 - Short-term mission teams (e.g., children's camps, evangelistic events, family days)
 - Periodic support visits (1–2 times per year)
3. **Most Needed Support Areas:**
 - Financial assistance
 - Human resources
 - Ministry training and development resources

Observations:

- **Southampton:** Church development is at a stage similar to Chinese churches in Toronto 20 years ago. Children's and youth ministry training is now a top priority.
- **Camberley:** The pastor is forming ministry teams and partnerships with local mainstream churches to serve the BNO community. Financial resources are a major concern, as weekly offerings are only around £100—insufficient for sustaining full-time staff.

Region Focus: Middle Region – Milton Keynes

Section I – Interviewee Background

1. Length of Stay in the UK:

Most respondents had arrived within the last 5 years, with children in primary and secondary school. Some single professionals were also present.

2. Reasons for Choosing the Region:

Milton Keynes is a post-WWII planned city with new infrastructure and modern housing. It was previously a preferred relocation site for Hong Kong immigrants under the British Nationality Selection Scheme (居英權計劃) in the 1990s. The existing Hong Kong-style community setup made it appealing to new BNO holders. The city is compact—easily navigated within 20 minutes.

3. Major Challenges Upon Arrival:

- Employment
 - Education
 - Language and cultural barriers
 - Family adjustments
 - Community integration

Section II – Church Situation and Responses

- **Milton Keynes** is home to four Chinese churches, three of which have been established within the past five years.
 - None of the churches currently own their own buildings, operating instead from rented venues or private homes.
 - New pastoral leaders are still in the process of settling in, adapting to local ministry needs and community dynamics.
 - Fellowships and ministries remain in the early stages of development, with foundational structures still being built.

Observations:

- Churches in Milton Keynes are experiencing a significant financial burden, largely due to the lower income levels within the congregation, many of whom are part of the recent BNO immigrant population.
 - Marriage and parenting challenges remain prevalent among Hong Kong families, particularly in navigating family life and raising children in a new cultural environment.
 - Due to tight financial constraints, local churches may struggle to host or support short-term mission (STM) teams.
 - There is also growing awareness and concern regarding the rise of the “Hong Konger Church” movement, as local churches fear it may undermine the unity of the broader Christian community.
 - The close-community mindset of local churches may present difficulties in building partnerships or cooperating in joint ministries.

Region Focus: North West – Manchester

Section I – Interviewee Background

1. Length of Stay:

Most families have been in the UK less than 5 years, with children in primary and secondary school. A large number of single young professionals also reside here.

2. Why Manchester:

Manchester is the UK's third-largest metropolitan area, offering lower living costs and better job opportunities. Chinese community has existed since the 1990s. The University of Manchester is another key draw.

3. Major Challenges:

- Employment
- Education
- Cultural adaptation
- Family dynamics
- Community integration

Section II – Church Situation and Responses

The Chinese Christian community in Manchester is primarily served by two church denominations: **Alliance Church and the Chinese Christian Church**. Both churches own their main church buildings and have established a stable presence in the city.

In addition to their primary facilities, both churches have rented additional locations to accommodate growth and support ministry expansion across different areas.

Alliance Church

- The Alliance Church demonstrates a mature and well-organized church structure. It hosts three worship services each weekend, with each service accommodating approximately 250 attendees. The children's and youth worship services, along with Sunday school programs, are all operating at full capacity.

- In addition to its main building, the church has established at least three satellite worship locations. These extended sites primarily operate in rented facilities and follow a home-based small group model to facilitate community engagement and discipleship.
- The church is supported by five full-time staff members, most of whom were hired within the last five years. Due to the growth in worship locations, several staff members are now responsible for rotating between sites to lead and support services.
- Furthermore, the Alliance Church has become a key connecting hub for short-term mission (STM) teams and evangelism initiatives, serving both its local community and broader outreach efforts.

Chinese Christian Church

- Recent revitalization driven by the arrival of BNO immigrants, with approximately 70% of members being new.
 - New worship facility recently acquired, with a seating capacity of 250 people.
 - Young professionals fellowship has been launched and is now active.
 - Three additional satellite gatherings have been established in residential areas, each serving around 100 -150 attendees.

Observations:

- **Alliance Church** is heavily engaged in existing ministry collaborations and may have limited capacity for new partnerships.
 - **Chinese Christian Church** is undergoing restructuring and would benefit from coordinated support rather than direct engagement from multiple groups.

Section V – Key Observations and Ministry Insights

1. **Employment Challenges:** Many BNO holders face significant barriers in the job market due to mismatched qualifications—being either overqualified or lacking UK-recognized certifications.
2. **Family Tensions:** Strained family dynamics are common, often caused by extended periods of close living conditions and limited access to local support systems.
3. **Church Financial Constraints:** Many churches are recently established and operate with limited donations, resulting in ongoing financial strain.
4. **Immigration Policy Uncertainty:** Uncertainty surrounding BNO immigration policies continues to be a background concern for many families.
5. **Outreach Potential:** Local estimates indicate there are over 170,000 BNO holders currently living in the UK, with approximately one-quarter identifying as Christians—highlighting a strong potential for gospel outreach.
6. **Shift in Evangelism Strategy:** Traditional STM approaches (e.g., distributing tracts, door-to-door evangelism) are increasingly ineffective in the current context.
7. **Relational Ministry Emphasis:** Effective ministry now relies on relational engagement, especially through home-based fellowships and local partnerships.

Regional Needs Summary

- **South West:** There is a significant need for children's and youth ministry training, particularly in culturally relevant and bilingual formats.
 - **Middle Region:** Family counseling and parenting seminars are in high demand, especially for parents adjusting to Western education systems and social norms.
 - **North West:** The current ministry focus is best supported by discipleship training and teaching resources to deepen spiritual growth among believers.

Strategic Consideration

- In cities like **Manchester**, direct contact with churches may place additional burden on local pastoral staff.
 - It is recommended that a **centralized mission agency** take the lead in coordinating with local churches, allowing for more structured and sustainable support.
